Criminal History Request and Disclosure Statement

State law (RCW 43.43) provides that an organization that educates, trains, treats, supervises or provides recreation to developmentally disabled persons or children under the age of 16 can require applicants for jobs or volunteer positions to provide certain information prior to appointment or service as a volunteer. In addition, the First Presbyterian Church of Kent reserves the right to request criminal history information for each employee, applicant, or volunteer from the Washington State Patrol, to determine if the person(s) being reviewed have any convictions or offenses against persons, adjudications of child abuse in civic actions or disciplinary board final decisions. **This information will be reviewed by the Personnel Committee in consultation with the Pastor prior to hiring or selection as a volunteer. All information obtained in this disclosure statement and/or from the WSP Criminal History records check will be kept confidential.**
